**MEETING CALLED TO ORDER**

Mayor Christopher Thornton called the meeting to order at 7:00 pm in the Brentwood City Hall Council Board Room located at 2348 S. Brentwood Blvd., Brentwood, MO 63144.

Members present constituted a quorum. Also present were City Administrator Bola Akande, Attorney Katherine Henry (in the absence of Kevin O'Keefe), and City Clerk Octavia Pittman.

**PUBLIC HEARING**

Mayor Thornton opened the public hearing at 7:00 pm.

A hearing was conducted to allow citizens an opportunity to voice their opinion regarding the 2016 proposed rate of tax levy per \$100 assessed valuation.

**Louise Charbonneau, Madge Ave**, questioned the correct rates being proposed.

Administrator Akande announced the reason to hold the hearing for the proposed tax rates. Due to the Assessor's deadline of October 1<sup>st</sup>, and the lateness of receiving the final numbers a special meeting is being held. The Library indicated a desire to raise their tax to the maximum approved by voters on 8/7/12. It was clarified that no limitation on when the rate expires if it is not elected to go to the full amount allowed.

**BILL #6089 – An Ordinance To Confirm, Ratify And Approve The Rate Of Tax To Be Assessed And Collected For Each One Hundred Dollars (\$100) Of Assessed Valuation For The Year 2014 For: (A) General Municipal Purposes; B) To Provide The Annual Contribution To The City Of Brentwood’s Police And Firemen’s Retirement Fund; (C) To Pay Principal And Interest As The Same Matures On Indebtedness Of The City Of Brentwood Evidenced By Bonds; (D) To Pay For The Maintenance Of The Public Library Providing For The Effective Date Of This Ordinance; And Providing For The Repeal Of All Conflicting Ordinances**
