No more than five (5) 7-day permits shall be issued to an applicant within a calendar year. Applicants must comply with all regulations pursuant to Section 605.550 of the City Code for the City of Brentwood, MO. Failure to comply with Brentwood's City Code may result in the revocation of permit.

Soliciting or Canvassing License Regulations

- A permit shall be valid for a period of seven (7) days from its date of issuance. No more than five (5) 7-day permits shall be issued to an applicant within a calendar year. (Sec. 605.520)
- Applicants will be charged a permit fee of \$5.00 per person, per day.
- No license or permit shall be issued to any person who has been convicted of a felony, a misdemeanor or an ordinance violation involving moral turpitude within the past seven (7) years. (Sec. 605.470)
- Any individual shall at all times while engaged in canvassing or soliciting in the City carry the license and it shall be worn on the outer clothing of the individual as so to be reasonably visible to any person who might be approached by said person in accordance with Sec. 605.510.
- Solicitors or Canvassers are not permitted to conduct their business in the following areas of the City of Brentwood, MO: Brentwood Forest Condominiums, The Villas of Brentwood, Hanley Station Condominiums, Brentshire Walk Apartments, Executive Walk Apartments, York Hills, York Woods, or Whitehall Ct.
