

A MESSAGE FROM BRENTWOOD MUNICIPAL COURT

You have been summoned to come to court on the date shown on your citation.

You may plead not guilty by coming to court and a trial date will be set.

You may plead guilty by mail or by coming to Brentwood Municipal Court's Violation Bureau to pay your fine.

If you plead guilty, you will be given a new court date to pay if you can't pay the date of court.

If you want to plead guilty, but you don't have the funds to pay your citation, you still must come to court. You will not be arrested for not having money to pay.

If you are indigent, you may be required to complete documentation to be determined by the court as evidence of your financial status and as an aid to the court in assessing fines, costs, and setting of a payment plan.

If you do not come to court when summoned to do so, you are subject to a warrant being issued for your arrest.

Pursuant to 479.050, RSMo, Supreme Court Rule 37.49, the undersigned Municipal Judge of the City of Brentwood hereby orders that the following designated offenses shall be payable to the City of Brentwood Violations Bureau. In such cases, no court appearance is necessary.

In accordance with Missouri statutes and ordinances adopted by the City, total court costs shall be \$22.50.

This includes Basic Court Costs of \$12.00, Crime Victim's Compensation Surcharge of \$7.50, Law Enforcement Training Fund of \$1.00 and Peace Officer's Standard Training Fund of \$2.00 for a total of \$22.50. Court costs shall be paid in addition to the fine.
