- The submission of this form does not serve as approval to distribute and consume alcoholic beverages within the Brentwood Community Center. Alcohol is prohibited in the Brentwood Community Center until your request has been officially approved by the Director of Parks & Recreation.

We are committed to providing a safe and secure environment where guests may enjoy alcohol in a responsible manner. Please read each rule listed below. We appreciate your cooperation in providing an enjoyable and safe experience for all guests at the Brentwood Community Center.

- An additional refundable deposit amount of \$100 is required for all rentals that have received official approval to consume alcoholic beverages on the premises. This \$100 deposit does not include the damage deposit amount paid for at the time of booking.
- Alcoholic beverages must be kept within the room that has been rented. No alcohol may leave the event space.
- Only beer and wine are allowed on the premises, hard alcohol is prohibited.
- Only beer served in aluminum bottles or cans is allowed. All glass beer bottles are strictly prohibited. 750ml wine bottles are allowed.
- For the safety of your guests, and in accordance with the State of Missouri liquor laws, we reserve the right to remove from the event space:
 - Any underage person who is consuming alcohol
 - Any person who provides an alcoholic beverage to an underage person
 - Any person who appears visibly intoxicated at the event
- If any of the aforementioned situations occur, it will result in a forfeiture of the entire alcohol deposit.

That decision is discretionary and lies wholly with the City of Brentwood, subject to its best interests as it determines them.
